PILLAR	Pillar principle: inclusion of people with disabilities (17)
CONTEXT	In many EU countries, the institutions and services evaluating the needs of people with mental health disabilities and supporting them, notice a particular difficulty with this population, especially with regards to finding them an employment. Professionals supporting this public notice that they have difficulty in formulating their needs and expectations with regards to their rights. Furthermore, people with mental health disability are exposed to the complexity of the system and, not considering themselves as disabled persons, don't request help. This complexity of the support system strengthens the isolation and the confusion felt by these persons. The institutions and services supporting them are facing many challenges: 1. to adapt to the needs of disabled people in order to guarantee the quality of the support provided (especially considering the changing nature of mental health illnesses); 2. to adapt ther practices to the need for more personalised and flexible support; 3. to ensure a more coordinated relationship with other structures and territorial actors working with people with disabilities; 4. to accurately inform professionals as to the best way to prevent and manage crisis; This project will allow the institutions, via the exchanges of best practices amongst professionals and vocational training methods, to

PURPOSE	The issue of adapting practices and skills of the service providers for people with mental health disabilities is central in this project. This adapting of practices and skills is possible with an innovative and efficient vocational training method. This creates the chance for people with mental health disabilities to understand better their needs, to be oriented to the best solution for each person and to improve his social and professional inclusion. Furthermore, all actors form the field, public policies, service providers, financiers, enterprises and associations have to be involved in the common thinking and in finding of solutions. The enterprises from the ordinary labor market don't know very well the specificities of mental health disability and how to deal with this public, and for consequence they don't offer them the opportunity to work. The mental health disability awareness of the society is also necessary for this project.

SPECIFIC OBJECTIVES	This inclusive approach requires innovative practices and vocational training methods. This project aims to exchange already existing or new innovating methods and good practices. This partnership brings together services which are facing the same problems and which are either interested or engaged in the resolution of these problems. Concrete objectives of the partnership are: to analyse, better understand and share the issues between the partners to identify and to understand better the challenges met by service providers, in particular in terms of staff skills and training; to formulate the strategies implemented by service providers and/or their funding authorities in order to resolve the key issues; to compare and assess practices in order to identify best practices.
SUSTAINABILITY	The recommendations and action's program that will be formulated in the end of the project in June 2019 could inspire the local governments and the different actors from the field. The idea is to realize some concrete actions improving the employment of people with mental health disabilities. Furthermore, the reflection about a new project Above within the Erasmus + program proposing an innovative training method is in the progress.

Employees are stressed about the management of BPSD of elderly and it depends on caregiver's personal attitude. Elderly is afraid of this moment and bath time negatively affect their mood all day long, this is why it's important to propose new solutions to guarantee the well-being of elderly with and without dementia.
